- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 3. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 60% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Buyer Added Bid Specific ATC

#### BUYER ADDED BID SPECIFIC ATC

- 1). Allowed makes for participation in the bid of **RO WITH UV EQUIPMENT** are: Lexpure/Aquaga urd (Eureka Forbes)/ Kent/ Voltas / Livpure / Pureit.
- 2). Rest makes shall not be considered for technical evaluation.
- 3). RO machine shall be of Wall mount type and without storage tank.
- 4) Availability of Test Report from central Govt./NABL/ Ilac Accredited Lab to prove Conformity to s pecification is **not required.**
- 5) Inlet pipe and fitting from Raw water source to the water treatment system and pipe & fitting fr om Outlet to Purified water tank **to be arranged or supplied by the seller.**
- 6). Water purifier shall be of ABS Grade type having three candles and machine shall be fitted with one UV lamp.
- 7). The bidder must agree to install the RO machine and provide CAMC at all the mentioned branches and satellite offices of Jammu and Kashmir including Leh.
- 8). **For Technical evaluation** the bidder must submit the following documents.
- a) Chartered accountant certified Proof of **Annual Turn over for FY 2021-22 and 2022-23** in s upport of condition of minimum average annual turnover mentioned in the bid document which st ate that "the minimum average annual turnover of the bidder must be Rs 300000.
- b) Copy of Work orders/ experience Certificate executed in FY 2022-23 & 2023-24 in sup port of experience mentioned in the Bid for years of Past experience i.e. 2 years which states as "t he bidder or its OEM (themselves or through reseller (s) should have regularly, manufactured and supplied same or similar products to any central/ state Govt organization / PSU/ Public listed comp any for number of financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied so me quantity during each of the financial year.
- c) Copies of Work orders/ experience certificate executed in FY 2022-23 & 2023-24in support of condition specified in Bid Condition for Past Experience of Similar Services which states as "The Bidder mu st have successfully executed / completed at least one single order of 60 % of the Estimated B id Value i.e. 3.03 lakhs or 2 orders of 50 % of the Estimated Bid Value i.e. 2.52 lakhs or 3 orders of 40 % of the Estimated Bid Value i.e. 2.02 lakhs for similar service(s) in last two years from bid publish d ate to any Central / State Govt Organization / PSU / Public Listed Company. Estimated Bid value is ₹ 50 5000/-
- d) Valid **OEM Authorization** Certificate for the current financial year (2024-25).
- e) A **self declaration** on the letter head of bidder must be submitted by the bidder that bidder/s upplier/ organization/ proprietor/ any/ of the Directors should not have been banned or suspended or blacklisted by any government/ public sector undertaking/corporate organization or convicted in anycourt of law across India or declared Bankrupt or insolvent.

The declaration submitted shall be dated during the bidding period i.e the declaration should have been **signed after the date of publishing** of the bid.

Post Warranty CAMC: A self-declaration on the letter head of bidder must be submitted by the bidder that it will provide :

- 1. CAMC for next five years from the date of expiry of warranty period of one year of the product.
- 2. CAMC will be provided for the offered product at the rate not more than 20 % of the product cost per annum .

Terms and conditions for CAMC

- 1) For RO With UV models, replacement of candles/Filters/ Membranes will be done at the comme ncement of CAMC and thereafter on half yearly basis.
- 2) For RO machines, replacement of RO kit as and when required.
- 3) All electronics parts replacement will be covered in CAMC.
- 4) Complaints in between CAMC period will be attended by the successful bidder free of cost.
- 5) The parts, components, sub assemblies used for repair / replacement by the service provider will be of same make and functional capability as originally available in the purifier. All types of spare consumables and accessories shall be available with the service provider for equipment covered under the contract. An undertaking is required to be submitted to this effect at start of C AMC services. Service provider shall ensure that only original parts of same make/brand are used for replacement.
- 6. The contract will be for **3 years**, extendable one time for **2 more years** on the sole discretion of LIC on the same terms and conditions.
- 7. No enhancement of rates will be allowed during the currency of contract period.
- 8. LIC reserves the right to terminate the contract at any time during the contract without assignin g any reason.
- 9. **CAMC amount will be paid in two half yearly instalments** after the completion & submissi on of service report (in triplicate) duly verified by the authorized signatory of our office along with the bill. Payment will be made directly into your account only through **NEFT.**
- 10. All the consumable articles / parts such as material required for cleaning, repairs and mainten ance will be provided by the service provider at no extra charges to the buyer. The spares and acc essories shall be of standard quality. The spares and accessories shall be compatible with purifier and according to the specification provided by the manufacturer and with best quality.
- 11. The service provider shall ensure visit by technician/service engineer in the beginning and the reafter every 6 months for routine check till the expiry of the CAMC period.
- 12. Ordinarily a complaint must be attended within the 24 hours when no change of spare part is i nvolved, however in case of requirement of change of spare part, the complaint should be resolve d within 72 hours of lodging the complaint, failing which **Rs. 100/- per day penalty** will be imposed.

### 2. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
