3.Comprehensive Annual Maintenance Contract (CAMC) shall cover all the items required for maintenance of the online UPS installed at various offices under DO Amritsar

4.Under the CAMC contract **Quarterly visits are to be made** at the above mentioned locations and pay ment of bills shall be done on Quarterly Basis on the submission of Bill along with Quarterly reports duly ve rified by the concerned LIC official of the respective Office.

5.Successful vendor has to appoint at least 2 (Two) local technician to attend the complaints and share the details within 15 days of award of the contract.

6.Preventive Maintenance in every quarter shall be carried out by the service personnel of the contractor d uring which system including UPS & Battery shall be cleaned (using blower / vacuum cleaner) and perform ance of the system & battery shall be checked to the satisfaction of the user. Replacement of battery term inal & wires if required etc shall be done during the visit if required.

7. The agency is advised to inspect and verify the conditions of the UPS before quoting their rates. Nothing shall be considered about the condition of the UPS once rates are accepted by the competent authority.

8.At the expiry of the contract the outgoing contractor shall have to make out the system in normal workin g condition. Payment for last quarter shall be released only after restoring the system to its normal workin g condition and or after recovering any dues payable to the contractor who executes the work at the risk a nd cost of the original contractor. The parts and components etc. which will be replaced during the contract t shall be of good quality and of reputed make to the satisfaction of the department. Old part replaced by t he contractor will become the property of the contractor

9.During the period of CAMC successful bidder shall attend to all repairs / defects / replacement of major / minor spare parts without any extra cost.

12. The Penalty amount will be recovered from the CAMC payment lying with the office. Complaint (s) will b e deemed to be resolved only on the availability of the customer call report signed by both the service eng ineer and Corporation's authorized official, conforming that the complaint is resolved. Date and Time of the resolution of the complaint shall be indicated clearly.

13.Penalty of 1% per week subject to a maximum of 25% contract value per year shall be levied, in case t he CAMC is not attended within time, then the same shall be got attended at Risk & Cost of successful ven dor.

14.In case of Partial / Full Damage or loss of equipment due to reasons beyond control of LIC like Theft, Fir e, natural calamity etc, the tenderer should be in a position to supply working standby equipment with sa me configuration or higher with all the services restored, as if it is a normal break down and cost of repair o f the damaged equipment will be borne by the corporation.

15.In the event of replacement of any part of the system, it should be done with a part of equivalent or hig her configuration which is compatible with the system.

16.Whenever any system has to be shifted from one LIC location to another, the vendor is required to unin stall / reinstall and maintain the system/s at the new location, at extra cost to LIC of India on account of rei nstallation with prior approval from the office.

17.Service Engineers / Representatives of vendor shall invariably carry their identity cards with them with out which they will not be allowed to access the systems.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
