

ANNEXURE F: Scope of Work

LIC intends to implement a secure, enterprise-grade **Co-Browsing Solution** to enhance customer support, improve policyholder experience and meet regulatory KYC requirements. The selected bidder will be responsible for the design, supply, implementation, and ongoing support of this solution. The system must seamlessly integrate with LIC's existing web and mobile applications, protect sensitive customer information, and offer a robust set of collaboration tools for agents and supervisors.

User Count: Five

Duration: 3 Years (36 months post Go Live).

Co-Browsing to be enabled as a feature in LIC's Onboarding applications that empowers LIC Support agents to engage with customers in real-time through Live Chat and support platform. It should allow LIC users to visually guide and assist customers by sharing their screens, providing a seamless and interactive support experience without additional software or downloads.

Minimum Capabilities / Features

- 1. **Zero Download on Customer Side:** The co-browsing experience shall work without requiring any plug-in or software installation on the customer's device.
- **2. Integration with LIC Webpages (eSales.licindia.in):** The co-browsing solution shall support direct integration with LIC's webpages, including eSales.licindia.in, for seamless customer assistance.
- 3. **Support Agents Login and Dashboard:** Provide a secure login and role-based dashboard for LIC support agents to manage sessions and view relevant metrics.
- **4. Dynamic Support Tab Display:** The system shall allow custom display of the support tab on LIC webpages based on the logged-in support agent. (No tab to be shown if no agent is logged in.)
- **5. Highlight Fields Using Marker:** The agent shall have the ability to highlight or mark fields on the customer's screen to guide them during a session.
- 6. Agents Initiated support url to the customer to invite for co browsing session.
- 7. **Masking of Sensitive Information:** PAN, mobile numbers and other sensitive data displayed on the screen shall be automatically masked from the agent side to ensure data privacy.
- 8. **Single Tab Sharing:** Only the active browser tab selected by the customer shall be shared, preventing inadvertent data exposure.
- 9. **Easy Integration in Web and Android Apps**: Provide SDKs/APIs for seamless embedding of co-browsing into LIC's web portal and Android/iOS mobile application.
- 10. **Video Recording for KYC**: Enable high-quality video recording during customer interactions to meet regulatory KYC compliance.
- 11. **Integrated Live Chat**: Provide real-time chat functionality within the co-browsing session for contextual assistance. Chat Summary to be available.
- 12. **Group Co-Browsing**: Allow multiple LIC agents/supervisors to join a session simultaneously for training or escalation.





13. **Capture Snapshot**: Enable agents to take and store screen snapshots during sessions for audit/compliance.

- 14. **VOIP/Voice Calling**: Built-in secure voice calling between customer and agent within the session.
- 15. **Document/Brochure Sharing**: Share PDFs, images or brochures directly during a live session.
- 16. **Geo-Tagging**: Capture and store customer location metadata (with consent) for fraud prevention and reporting.
- 17. **Reporting and Analytics**: Provide dashboards and downloadable reports on session metrics, usage, agent performance, and KYC recordings.


