Following treatment shall have to be done:-

- All dirty water along with sludge shall have to be removed with special vacuum pump.
- All sides of tanks shall have to be cleaned with pressure cleaning techniques.
- Antibacterial agents, sterilizing agents shall have to be sprayed in the tank using pressure machine.
- Tanks shall have to be dried using cleaned mops and special vacuum pump.
- Water tanks shall have to be white washed form inside.
- ➤ Ultraviolet radiator/H.A.B. machine shall have to be used in the tank, after completing above process.

Terms and conditions

- * Rates quoted should be inclusive of all taxes and no extra on any account should be paid. GST will be paid as per Government norms.
- ❖ Income tax will be deducted as per rules.
