Tender for Re-filling of Fire Extinguishers

Sealed Tender is invited for Refilling of Cylinders as per specifications mentioned in the “Annexure –D” & “Annexure –E”.

The bidders may collect the tender documents from the office at the above address. Tender documents will be issued from 23.04.2025 to 07.05.2026 between 10.30 AM to 3.30 PM on week days (excluding Holidays, Saturdays & Sundays).

The Tender fee of Rs 118/-(including GST) per tender (non refundable) is required to be deposited in cash/DD at our cash counter in F&A department and copy of receipt should be produced and submitted before issue of tender. Please submit/bring (in case of Cash payment) copy of GST Registration Certificate in Form GST REG-06/25 and PAN of the firm/agency. In case the tender fee is not deposited while collecting tender form from our office, the duly filled up tender should be accompanied with a D.D. of Rs.118/- favouring LIC of India payable at Silchar. **Tender fee will not be required if the tender documents are downloaded from our website by the bidders.** The last date of submission of filled in tenders in the tender box is 08.05.2026 up to 3.00 PM at our office OS Department, LIC of India, Silchar Divisional Office, Meherpur, Silchar, 788015.

TENDER OPENING SCHEDULE -: Technical bids of all tenders received within stipulated Date & time will be opened by our “Tender Opening Committee” on 11.05.2026 at 11.00 AM. All Bidders are requested to remain present or send only one Representative with Authorization Letter of the Firm during Tender opening Session.

The tender application must be accompanied by EMD (Earnest Money Deposit) of Rs. 4727/- (One Thousand Seven hundred twenty only) by DD in favour of LIC of India payable at Silchar. FDR's will not be accepted . EMD of unsuccessful bidders will be refunded without interest within one month from the date of finalization of tender. Tender without EMD will be subject to rejection. (MSME & NSIC Registered vendors are exempted from submission of EMD subject to production of valid certificate). No Brokers/Intermediaries shall be entertained. The Sr. Divisional Manager, Silchar Division reserves the right to accept or reject any or all offers in full/part without assigning any reasons whatsoever. Financial bids of only the bidders qualified in technical bid evaluation will be opened at a later date as will be decided by the competent authority.

1. Envelope No 1- marked as “Technical Bid” sealed and containing -
 - (a). Tender Fee Rs. 118/- (Including GST) by DD in favour of LIC of India payable at Silchar (in case Tender Fee not deposited in Cash at DO Silchar). **Tender fee will not be required if the tender documents are downloaded from our website by the bidders.**
 - (b). EMD of Rs 4727/- by DD in favour of LIC of India payable at Silchar,
 - (c). Tender documents/ Offer Letter / Annexure - ‘A’, ‘B’, ‘C’ & other relevant documents with seal and sign on each page

General

1. **Delivery & Completion:-** Re-filling of fire-extinguishers as per ISI specifications should start within 15 days from the date of work order issued to the successful vendor and should be completed in a phased manner. Each lot should be reinstalled within 7 days from the date of taking up the lot, failing which penalty of 0.5% per week of the total contracted refilling cost of the lot will be charged for the delay subject to maximum of 5%. When fire extinguishers are taken for re-filling, the vendor shall provide temporary replacement at no extra cost whatsoever till the fire extinguishers are brought back and installed.
2. Refilling work would be carried out in consultation with Officers of LIC in DO/BO. Random Testing of the quality of MAP powder at the time of refilling will be carried out by LIC.
3. The testing should be carried out with pressure prescribed as per specification of ISI Standard. One or two fire extinguishers of each category should be tested to ensure satisfactory compliance. Cost of testing will be borne by the Vendor.
4. After awarding of order, in case of unsatisfactory services and/or failure to complete the job in time, LIC of India reserves the right to terminate the contract, black-list the agency and forfeit the EMD, Security Deposit.
5. The EMD of unsuccessful bidders will be refunded without interest within a period of 30 days from the date of issuing work order to the Successful bidder subject to clearance of the amount. However, in case the successful bidder backs out/withdraws before/after the work order is issued, then, his/her EMD will be forfeited and the Vendor/agency will be black-listed.
6. LIC reserves the right to cancel one or all tenders without assigning any reasons whatsoever.

7. Envelope-1 should be sealed and superscribed as "Technical Bid", and shall contain the following:

Offer Letter, Annexure A, B, C along with copies of required documents.

Tender document duly stamped and signed on each page as token of acceptance of all terms & conditions laid down Offer letter, Tender fee Rs. 118/-, EMD of Rs. 4727/- in the form of DD favouring "LIC of India" payable at Silchar. **This envelope should not contain any document related to financial bid/quotation. If after opening of envelope-1 any such document is found therein, the tender of that particular bidder will be liable to be cancelled.**

Envelope-2 shall be sealed and superscribed as "Financial Bid" and shall contain the following:

The Envelope-3 shall be sealed and superscribed as "Tender for re-filling of fire extinguishers in Assam, Manipur and Mizoram" and shall contain the Envelop number- 1 and Envelop number -2.

Please note that, Rates quoted for Re-filling of fire extinguishers should be **per cylinder and including GST** and in the format given in the tender document ie ANNEXURE - D & ANNEXURE- E. Submission of Financial Bid in any format other than the format provided in the tender document or submitted for some types of Specifications only will not be accepted and the bid will be rejected.

8. The rates quoted in the Financial Bid shall be inclusive of Transportation Charges, Technicians Fees, TA/DA any other expenses whatsoever and **also inclusive of GST & all taxes**. The rates must be quoted in INR only (not in paisa). **The Rate per cylinder quoted for Re-filling of Fire Extinguishers in the Financial Bid as in Annexure D would be considered for finalizing the L-1 bidder.**
9. The successful bidder shall have to deposit a sum equivalent to 5% of the Contract Value as Security Deposit, which in the event of not carrying out the contracted services as per the terms and conditions of the tender, shall be forfeited. Security Deposit in the form of DD favouring "LIC of India", payable at Silchar shall be deposited within 7 days of awarding the tendered job to the vendor. Security Deposit without interest will be refunded at the time of final settlement after satisfactory completion of work.

10. Initially the Period of contract will be for one Year, which may be further extended by one Year (Maximum two extensions of one year each) if both the parties are mutually agreed on same Rates and Terms & Conditions of the said Contract.
11. Payment to the vendor through NEFT shall be made after satisfactory completion of the work.
12. Disputes, if any, shall be considered to be within the jurisdiction of Courts in Silchar.
13. The vendor will carry out the re-filling of existing fire extinguishers which shall include:-
 - a. Replacement of defective spare parts like discharge tube, nozzle, horn water, washer, Plunger etc at the time of re-filling as per approved rates subject to prior approval
 - b. Repair of fire extinguishers, if required but subject to prior approval of LIC.
 - c. Refilling charges quoted shall include re-filling of gas cartridges
 - d. Replacement of small spares like rings/washers to be done at no extra cost
