2. General Terms and Conditions-

- 2.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.
- 2.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable
- 2.3 All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and
- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

3. Buyer Added Bid Specific Terms and Conditions-

3.1 Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period}$ (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

(1) As the current FY ended recently, Certified Audited Trading and P&L account, Balance Sheet/CA Certificate for any 3 successive FY out of the last 4 FY (2022-23, 2023-24, 2024-25 & 2025-26) is required to meet the minimum average annual turnover criteria.

(2) Both the items under each Schedule for Envelopes (Schd-1) & Envelopes-Policy Dockets (Schd-2) have some additional specifications with regard to Paper quality, Exact size, GSM, Printing etc, so Seller must go through the additional specifications very carefully before participating/quoting their rates in the bid.

(3) In Schedule 2, the exact envelope (Policy Docket) size is 14x6 inches & the paper quality is 130 GSM Reinforced Bituminised (Tar Coated) Star Craft water proof paper with synthetic yarn and black color single side printing

(4) Seller will be required to print logo and other details as per additional specifications/ buyer's requirement for the respective products.

(5) After award of contract, the supply should be made as per staggered supply schedule of the respective product. 1st lot will be supplied within 35 days from the date of contract which includes 5 days for getting the artwork/design approved on vendor's part.

(6) Acceptable GSM range 76-80 GSM for Schedule-1 and 124-130 GSM for Schedule-2. In case of GSM found below the acceptable range, proportionate recovery or rejection of supply will be decided by Competent Authority depending upon merits of each case.
