The ARC contract for Civil as well as Electrical of all the properties under jurisdiction of Divisional Office Dehradun is expiring on 31.03.2024, as per our office Note dated 09.10.2023(Copy enclosed). Hence now it is required to inviting e-tender from the suitable empanelled vendor for smooth functioning of various offices.

It is proposed to invite percentage rate e-tenders on existing zonal office standard schedule of rate, received from SE/Zonal office vide e-mail dated 28.06.2023. (Copy enclosed)

Needless to mention that M/s KN Goel is not suitable for ARC tender because he is entitle for 2.0 lacs only and M/s India Electrical & Engineering works- Unnao (U.P.) is not interested to do the works allotted to them, verbally and also communicated by mails, in recent past, and has not even responded to our e-mails. The details of email are enclosed. Mails dated 10.01.2024, 06.01.2024, 04.10.2023, 20.04.2023, 15.05.2023, 27.02.2023, 22.06.2023, 08.08.2023(Copy enclosed). The contractor always willing to do big nature of works on pick & choose basis but purpose of ARC is for suitability of LICI, solution of complaints in short period without tendering, to avoid time delay in solving the problems.

But due to this tendency of M/s India Electricals, our offices & licensees has been suffered in past. The contractor have also deputed irresponsible person who does not have sufficient technical knowledge to do the works & main contractor had left DO-Dehradun since May 2023 as transfer of AEE (civil) has been made. Due to this behavior of M/s India Electricals, LICI had to suffer a lot to execute essential & emergent nature of works. Our correspondence as made confirms such incidents & enclosed for your kind perusal. In view of above, it is proposed that both the agencies M/s KN Goel, Dehradun & M/s India Electrical & Engineering works- Unnao (U.P.) are not suitable agencies, hence may not be allowed to participate in the current tender process.
