Note to Sr. Divisional Manager

Re: Fresh Tender for Hiring Premises at Panagarh for Panagarh Branch and Tender for Hiring Premises at Rampurhat for Rampurhat Branch

Consequent upon the tender floated on 14.09.2023 for Hiring of premises on lease basis for Branch Office at Panagarh the Competent Authority has approved the cancellation of said tender on technical ground as only one bidder has qualified in the tender, vide dated.

Under these circumstances we may precede for fresh tender process with the same terms and condition after one month from the date cancellation of the previous tender which already informed the respective bidder, vide dated 28.11.2023.

As the process of Shifting of Rampurhat BO failed at Municipal Building vide their letter dated 20.09.2023, where the Municipal Authority expressed their inability to lease on hiring basis we are to go for tender process for Hiring Premises on lease basis for this branch also.

With reference to the mail vide: ez_estate dated 16.10.2023 once PPC approval is given it remains valid.

In view of the above situation we propose to go for Tender for Hiring for Branch premises on lease basis at Panagar and Rampurhat.
